

Simpson County Youth Camp Camper Behavior Contract

As an applicant to Simpson County Youth Camp, I, _____
(Camper's Name)

agree to the following concerning participation at Taylor Christian Camp or at any other location visited as part of the Simpson County Youth Camp week/ministry.

___ I agree to not use or bring or have in my possession alcohol or drugs other than those approved or specified by the camp doctor/ nurse, director, or partaking of any other prohibited substance.

___ I agree to leave at home any items which are weapons or weapon-like.

NOTE: A violation of the above will result in immediate expulsion from Simpson County Youth Camp with loss of tuition at the parent's effort and/or expense.

___ I agree to not bring, use, or have in my possession any tobacco or vaping products.

___ I agree to respect the SCYC curfew/lights out and not be out of my cabin unless accompanied by a staff member.

___ I agree to respect the authority of the SCYC staff, following their directions and accepting their decisions. This includes instructions for "lights out," as well as to cease any other activities for whatever reasons that they might have.

___ I agree to not leave camp for any reason without the permission of the camp director. For insurance purposes, **ALL** staff, campers, visitors must sign-in and out with the camp director during the week. The sheet will be located in the lodge.

___ I agree to avoid coupling and going off to talk alone (or to do anything else as couples, for that matter). Regardless of the nature of the relationship, camp is a time for group inclusion & fellowship.

___ I agree that no girls are allowed in or around the boys' cabins and vice versa. No exceptions!

___ I agree to attend all camp activities as designated by staff, to arrive on time, and to respectfully remain there until dismissed.

___ I agree to respect the needs and feelings of others, to show kindness to all that I meet, and to help whenever I can.

___ I agree to abide by the Dress Code: Modest dress is expected at all times! Clothing **NOT ALLOWED** will include: any clothing that is tight fitting, too small, low cut (midriff must not show), spaghetti straps, revealing cutoff shirts (Note: Sleeveless shirts may be worn, but must be 2 inches wide across the shoulders.) Undergarments must not be showing outside of your clothes. Swimwear should be appropriate length trunks for boys, and girls must wear one-piece swimsuits or dark-colored t-shirts that will cover two-piece swimsuits. Anyone (campers, staff, and/or visitors) dressing inappropriately/immodestly will be asked to change immediately.

___ I agree to bring only those items approved by the camp directors (see camper's packing list) and to leave home those things which are neither appropriate nor allowed by the camp. This includes MP3 & other music players, iPads, computers, game systems, and luxury items and that if I have one in my possession, it may be confiscated for the duration of camp. **Phones may be used for picture taking only outside of the cabins.**

___ I agree that cabins are to be cleaned daily and will be inspected. If a cabin is not at or above a passing mark based upon inspection, the cabin residents and counselors will be instructed to clean up before other activities take place. Cabin cleanliness guidelines will be posted in each cabin during the week.

___ I agree that there are no overnight visitors without permission from the camp director. (Based on space availability.)

___ I agree to refrain from any and all unchaste language, gesturing, and behaviors. This includes using profanity, engaging in, or seeking to engage in sexual behavior, dressing or behaving immodestly, or in general, willfully giving into or leading others into temptation.

___ I agree to refrain from all violence, including physically or verbally abusing my fellow campers and staff. This includes bullying, fighting, yelling, and in general losing my temper.

___ I agree to respond to all harsh words, threats, taunts, insults, and attacks without returning like for like, "eye for an eye," but to seek a peaceful resolution to the problem, including but not limited to seeking the help of camp staff and/or simply walking away from the situation.

___ I agree to respect all property including housing, athletics, outdoor and indoor facilities that belong to TCC or SCYC as well as the personal property belonging to my fellow campmates.

___ I agree to pursue the fun and enjoyment of this camp experience whole-heartedly and in the spirit of Christian fellowship!

NOTE: A violation of the above will be dealt with according to the severity and may include, but not be limited to, being prohibited from participating in some or all activities, a call to a camper's parents, expulsion from camp with loss of tuition, reimbursement for damages and/or being prohibited from returning to this camp program.

I have read and understand the above SCYC Camper Behavior Contract and agree to follow these policies during my participation in the Simpson County Youth Camp. I understand that should I fail to comply with these policies; the consequences as stated above will apply.
